Every person should check their car insurance policy NOW and make sure their SUM coverage matches their liability limits.

#### Why You Need to Check Your Policy

Drivers assume they are fully covered but learn, after a crash, that their policy has no SUM/UM coverage. This type of SUM/UM coverage is not very expensive and bridges insurance gaps. It gives you access your own policy's limits when the careless driver's insurance falls short.
